



## 2007-2008 ENERGY STAR® APPLIANCE REBATE PROGRAM

### **Program Guidelines Effective October 1, 2007**

Rebates for the purchase and installation of qualified Energy Star® certified appliances are available to all eligible residential customers of Public Utility District No. 1 of Lewis County. The rebate is based on the appliance purchased. Rebates available are as follows:

Energy Star® certified clothes washers – Must have a MEF  $\geq 1.72$  and WF  $\leq 8.0^*$ . Electric water heating qualifies for a \$70.00 rebate. Use of gas, propane, or any other water heater types other than electric will be eligible for a \$25.00 rebate. Dryer can be any fuel type.

Energy Star® certified freezers – Must be a full size (volume  $\geq 7.75$  cu. Ft.) to be eligible for \$12.00 rebate

Energy Star® certified refrigerators – Eligible for \$25.00 rebate.

Energy Star® certified dishwashers – Must have an Energy Factor (EF) rating  $\geq 0.65^*$  to be eligible for \$25.00 rebate.

***Only one appliance per application allowed.*** Qualifying Energy Star® appliances must have been purchased after October 1, 2006 to be eligible for the rebate. All rebate requests must be submitted within 12 months of the purchase date noted on the sales receipt to be eligible for payment. Rebates will **NOT** be paid to contractors, installers, distributors, or retailers.

Until such time as this program's parameters change, the rebate is available to multi-family units of any size. In multi-family buildings, an application form must be filled out for each housing unit in which a Energy Star® certified appliance has been installed.

This program will remain in effect as long as there is funding available for it to continue.
