



2010-2011 WATER HEATER REBATE PROGRAM

Program Guidelines Effective October 1, 2010

A \$25.00 to \$45.00 rebate for the installation of each energy efficient electric water heater is available to new and existing single family and multi-family residential dwellings

All rebate requests must be submitted within 9 months of the purchase date noted on the sales receipt to be eligible for payment. The rebate will be payable only to the property owner or owner representatives. Rebates will **NOT** be paid to plumbing contractors, installers, distributors, or retailers.

Prior to the rebate payment, a permanently installed electric meter must be in place. A rebate will not be paid until such time that a permanently installed electric meter has been activated with Lewis County P.U.D. No. 1.

Efficiency Requirements - The water heater must meet minimum efficiency ratings based on the volume of the tank and length of warranty. These are as follows:

80	20+	0.92	\$45.00
105	20+	0.91	\$45.00
119	0-19	0.85	\$25.00

Rebate will be paid in the form of a credit on your electric bill

Until such time as this program's parameters change, the rebate is available to multi-family units of any size. In multi-family buildings, an application form must be filled out for each housing unit in which a qualifying water heater has been installed.

If the water heater is installed in an unheated area or located over an uninsulated floor (i.e. slabs), it is recommended that an insulated pad rated R10 or greater be placed under the unit.

Lewis County P.U.D. reserves the right to inspect and approve an applicant's water heater for conformity to program requirements.
